TO PARENTS WITH CHILDREN IN MUNICIPAL DAY CARE during the year of activity 2022–23

The day care fee is adjusted starting from 1 August 2022 in accordance with the index adjustment of the Ministry of Education and Culture. After that the highest rate is EUR 295 per month and the lowest rate that can be charged is EUR 28 per month.

Simultaneously with this adjustment of the day care fee we now also request you to submit the annual statement of your family's income so we can determine the day care fee.

The education committee reserves the rights to check correctness of given information. If it comes out that the fee is based on incorrect information given by the guardians the fee can be corrected retrospectively for maximum one year.

The statement of income should be submitted at the latest 31 August 2022

If you don't submit the statement of income by the deadline, you accept the highest day care fee, i.e. EUR 295 per month.

A concluded agreement on the amount of day care days/month must be in effect at least two consecutive months before a new agreement on changed need of care days can be concluded. An exception can be accepted only if the need of day care changes because of that the number of the guardians job days increases.

Fee percentages and minimum gross income limits are as follows from 1 August 2022:

Family size persons	Minimum gross income limit 1.8.2020 EUR/month	Fee % 1.8.2022
2	2913	10,7 %
3	3758	10,7 %
4	4267	10,7 %
5	4777	10,7 %
6	5284	10,7 %

If the size of the family is bigger than six, the income threshold for determining the fee is increased by EUR 197 for each additional minor child in the family.

Example of how the day care fee is counted

Family size is 3 persons.

Minimum gross income limit/month: EUR 3758

Family's gross income is e.g. EUR 3999

$$4020 - 3758 = 262 \times 0,107 (10,7 \%) = 28 \text{ EUR per month to pay}$$
